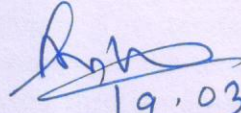


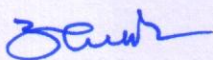
## SALE OF TENDER/BID DOCUMENTS

A complete set of bid documents can be downloaded from hospital website available at [www.svppgip.org](http://www.svppgip.org) directly from dt.20/3/2025. The tender paper cost fee of Rs.2000/- (Two thousand only) (non refundable) to be deposited in the form of DD to in favour of Superintendent, SVPPGIP, Cuttack along with technical bid of tender bid. The Bidders should specifically super scribe "The tender for supply of lab chemicals" over the envelope. The tender paper fee cost and EMD amount should be submitted separately in separate demand draft along with the technical bid. In case of any bid amendment and clarification, the responsibility lies with the bidders to collect the same from the website or the office notice board before last date of purchase of tender document and the Superintendent, SVPPGIP, Cuttack shall have no responsibility for any delay/ omission on part of the bidder.

The tender paper will be rejected if the bidder changes any clause or annexure of the bid document downloaded from the website.

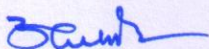

## **BRIEF INSTRUCTION TO THE BIDDERS**

### **1. TERMS AND CONDITIONS**

- 1.1 Sealed tenders will be received on or before dated **2/4/2025** up to 5.00 P.M. by the Superintendent, SVPPGIP, Cuttack from intending supplier for Supply of Lab Chemical items. Any tender received after the due date & time will be rejected / returned to the sender unopened. In the event of the date being declared as a holiday from the Govt. , the due date submission of bids and opening of bids will be the following working date & time in absence of any notification issued by purchaser.
- 1.2 The bidder(s) are to submit their tender in separate sealed covered envelopes for technical bid and commercial bid by super scribing Cover "A" (Technical Bid) & Cover "B" (Price Bid) and both the covers should be put into a third Cover, which should be super scribed as "Tender for the Supply of Lab Chemicals".
- 1.3 The tenderer should furnish EMD OF Rs.5, 000/- (refundable) in the form of BD.
- 1.4 The selected tenderer should submit the security deposit in the form of BD of Rs.50, 000/- to be pledge in the name of the undersigned.
- 1.5 Bidders have to bid for at least 60% of the items for which this tender is invited.
- 1.6 The Sealed tenders "Cover A" (Technical Bid) will be opened at the conference hall (new building) of Superintendent, SVPPGIP, Cuttack on date **4/4/2025** at 3.30pm. The tenderer or their duly authorized representatives are allowed to be present during the opening of the tenders if they so like. Any deviation of the scheduled date, the bidders will be intimated through SMS/e-mail/ whatsapp before 24 hours of the scheduled time. Therefore the bidders shall have to reflect their e-mail ID/ whatsapp number along with the bid document.
- 1.7 No tender documents can be accepted after the expiry of scheduled date and time for receipt of bids.
- 1.8 Firm should mention the items quoted, brand name in a check list sheet.
- 1.9 Each and every page/pages of the tender document should be serially numbered and duly signed by the tendered with stamp.
- 1.10 All entries in the tender form should be legible and filled carefully and clearly. Any overwriting may likely to rejection.
- 1.11 The bidder selected during document check should produce sample before the committee if sample test required. This must be produced either after the opening of technical bid or before the date of opening of financial bid as duration will be mentioned in the letter.
- 1.12 After evaluation of technical bid, check list & sample by the committee the bidder pass will be selected for price bid opening.
- 1.13 The quoted price shall not more than the MRP.
- 1.14 The approved price will remain valid for one year and no request for enhance of price within the period will be accepted.
- 1.15 The firm should read the terms and condition carefully before participating in the tender and no request for any addition or deletion shall be entertained.
- 1.16 The concern firm has to give declaration on agree of terms and condition in the tender paper.
- 1.17 If the firm/s who fails to supply particular item of an order within stipulated period, the approval of the said item will be cancelled and the firm will be penalize as per tender committee decisions subject to maximum of the performance security amount. Three times defaulter in like manner is lead to forfeit the all security amount and shall be debarred to participate in any of the tender of SVPPGIP for a period of five years.
- 1.18 All NBS Test parameters (81-88) should be quoted of same company by the bidder concern.



- 1.19 Dried blood spot collection card should have at least 6 spot/circles in one card for enough sample collection.
- 1.20 All the items (81-88) supplied should have self-life three fourth of the total life period of the product.
- 1.21 All the kits (81-88) should be smallest pack size.
- 1.22 The supplied test kits and reagents (81-88) shall have either CE or FDA approval.
- 1.23 All the quoted items (except sl no.81-88) supplied should have minimum one year self-life at the time of supply.
- 1.24 The firm quoted for the product at sl no.81-88 must mandatorily quoted price of sl no.48 &75 failing which the price evaluation in respect of sl no.81-88 will not be made.

## **2. ELIGIBILITY CRITERIA**

Bidders are eligible to participate in the tender provided, they have.

- 2.1 The firm should registered (GST) in any state or Union Territory.
- 2.2 The firm should have valid Drug license to sale Lab chemical items in retail or wholesale.
- 2.3 The firm should have minimum one year experience of successfully supply of Lab chemical items to any govt./ private/public sector hospital or more without failure of a single item.
- 2.4 Pan card should be in the name of proprietor or firm.
- 2.5 The firm must have business turnover of not less than 30 lakhs during last year (2023-24)
- 2.6 The firm should not black listed either by the Tender inviting authority or by any state Govt. or Central Govt. organization.
- 2.7 The firm must submit last month (February-2025) GST Return along with the technical bid tender.

**The following documents should be enclosed in Cover "A" (Technical Bid) by the tenderer.**

### **3. COVER—A (TECHNICAL BID) (Format as per ANNEXURE-I):**

- 3.1 Earnest Money Deposit of Rs. 5000/- (Five thousand) in shape of Bank Draft.
- 3.2 Copy of Valid Drug license or if applied for renewal then the challan copy of deposit and receipt copy of the concern authority for renewal of before expiry to be submitted.
- 3.3 GST Registration Certificate.
- 3.4 Photo copy of Pan Card of firm/proprietor.
- 3.5 GST return copy of last month (February -2025) or up to Dec-2024 in case of quarterly return.
- 3.6 Tender paper cost of Rs.2000/- (Two thousand) in the shape of BD.
- 3.7 Copy of minimum one year supply experience to any govt./private/public sector hospital of at least 100 beds or more. Supply order copy must be submitted in support of experience. More than one year experience will carry more weightage in case of equal rate in price bid. Similarly, the suppliers supplied through GeM (Amounts involvement for such supply) will secondly carrying the weightage in case of equal rate in price bid.
- 3.8 Copy of C.A certified sheet of the year 2023-24 in support of turnover of rupees 30 lakh or more.
- 3.9 Copy of one year IT return 2023-24 (Assessment year 2024-25).
- 3.10 Declaration through affidavit before Notary Public / Executive Magistrate regarding non black listed by any state Govt. or Central Govt. organization.
- 3.11 Detail of list of item quoted with specification and brand name must be submitted.
- 3.12 Details name, address, telephone no., whatsapp number Fax, e-mail of the manufacturer / authorized distributor / contract person must be reflected.
- 3.13 The downloaded Tender Book and the schedules signed by the tenderer at the bottom of each page with his official seal duly affixed.

### **4. COVER – B (PRICE BID) (Format as per ANNEXURE-II)**

- 4.1 The tender format giving the quoted rate for the items should be sent in a separate sealed cover hereafter called Cover "B" (Price Bid). The Cover –B (Price Bid) will be opened only of the tenderers who qualify in Technical Bid (Cover – A) and product is as per tender specification.

4.2 The tender must be submitted the unit price of the items (Items in ANNEXURE-III) inclusive of packing, forwarding, freight (delivery at site), but exclusive of GST in Cover-B with brand name.

4.3 The rate should be quoted for each item & each size separately (unit price) both in figures and words. In case of difference in words and figures, words will be taken into consideration for evaluation.

#### 5. PRICE EVALUATION:

5.1 Tenderers who qualified in technical bid and in specification will be evaluated only.

5.2 The cost of Item inclusive of the transportation, packing, forwarding and FOR central store, SVPPGIP, Cuttack but excluding GST.

5.3 The conditions provided in the term & conditions at section 1 will be followed in the process of evaluation.

#### 6. DELIVERY OF TENDER

6.1. The date, Time and Venue for delivery of tender is as per schedule mentioned in front page of tender paper.

6.2. The Hospital authority will not held responsible for postal delay to reach in the office before the last date and time.

#### 7. SAMPLES

7.1. The tenderer have to provide sample (small pack) of the required item if tender committee desire to test the quality. This must be produced either after opening of technical bid or before the date of opening of financial bid. Failings to provide, the said item shall not be considered.

#### 8. EARNEST MONEY DEPOSIT:

8.1 The tender should be accompanied with Earnest Money Deposit (EMD) amounting **Rs.5000/-** (Five thousand) in shape of Demand Draft from any Nationalized/ Scheduled Bank in favor of Superintendent, SVPPGIP, Cuttack.

8.2 **Tender without EMD will not be considered and rejected.**

8.3 The EMD of the unsuccessful bidders will be return back after finalization of tender without interest.

8.4 The EMD of approved firm/s will be returned after submission of security deposit.

#### 9. SECURITY DEPOSIT:

9.1 The firm/s has/have to submit security deposit of **Rs.50,000/-** in the form of bank Draft from Nationalize bank.

9.2 Security deposit will be returned after validity of tender is over without interest.

9.3 The selected firm has to complete the supplies within 14 days from the date of issue of purchase order depending on the situation.

9.4 If the firm/s fails to accept the purchase order or supply the item/s of ordered quantity, within the stipulated period, the approval of the said item/s will be cancelled. Three times defaulter in like manner is lead to cancellation of all the approved items and forfeit the total security amount and the firm/s will be bar to participated institution tender for five years.

9.5 If the supplied item/s are not up to standard quality the firm shall have to replace with good quality. If the firm fails to replace then the approval will be cancelled.

#### 10. REJECTION OF TENDER

10.1 Non submission of any one document or valid in technical bid, the tender shall be rejected.

10.2 Non adherence to any of the condition at item 1-9 is liable for rejection.

10.3 If the documents /information or declaration submitted by the bidder/s found false at any stage, the tender shall be rejected.

10.4 Any conditional tender beyond the clauses of this tender schedule will be rejected.

**11. PAYMENT:**

11.1 Bills can be generated by the Seller on completion of supply of the ordered item/s of the purchaser and accordingly Payment will be made.

11.2 The payment may delay due to unavailability of fund and have to wait till fund available from Government. The firm should not stop supply or pressure for payment.

**12. BID VALIDITY**

12.1. The validity of the tender is for one year from the date of award for such or finalization of next tender whichever is earlier.

**13. LIQUIDATED DAMAGE:**

13.1 The Superintendent, SVPPGIP, CTC may allow extension for a maximum period of 1 weeks (7days), after the stipulated date of supply (i.e. 14 days) with a penalty of 0.5% which will be deducted from the purchase order value as "Liquidated Damage", for each week (7 days) up to a maximum 2% on the value of the goods.

13.2 If the supplier fails to complete the supply within the extended period, i.e 21 days after being allowed by the Superintendent, SVPPGIP, CTC, no further purchase order will be placed to the firm for the said item.

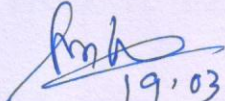
**14. GENERAL CONDITIONS:**

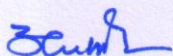
14.1 The authority reserves the right to accept /reject all the bids or any part thereof without assigning any reason thereof.

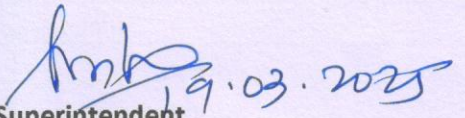

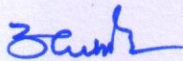
