The Superintendent , SVPPGIP, Dist-Cuttack, Odisha invites sealed tender from competitive parties for outsourcing of Bio-Medical Waste Management systems of SVPPGIP, Hospital (416 beds). The tender should contain both Technical & Financial bids separately. The Technical bid will be opened first and financial bid will be opened later to those who will qualify in the technical bid. The work includes collection of biochemical waste from the segregation site, transportation & its disposal in the available facility in SVPPGIP, Cuttack. The waste for incineration is to be disposed at incinerator at SCB Medical College & Hospital as required. The charges to be quoted per bed per day including cost of poly bags, and cost of transportation of waste for incineration at SCB Medical College as required, excluding of GST by the bidder. The bidders have to download the tender documents directly from the web site **www.svppgip.org**. The tender should be submitted in two bid systems. Cover-A for Technical bid and cover-B for Financial bid. Cover-A & Cover-B to be sealed separately and both the envelopes to be sealed in another envelop. The tender cost fees of Rs.1000/- (One thousand) (Non-Refundable) and EMD amount Rs 5000/- (Refundable) in the form of demand draft drawn in favour of Superintendent, SVPPGIP, Cuttack payable at Cuttack should be enclosed in technical bid. The bidder should specifically super scribe" Tender for Biomedical waste management", over the outer envelope containing bid. In case of any bid amendment and clarification, responsibility lies with the bidders to collect the same from the web site or from the office notice board before last date of submission of tender documents and the superintendent shall have no responsibility for any delay / omission on part of the bidder. The tender have to reach at the office of the Superintendent .SVPPGIP, Cuttack on or before dated 26/06/2018. Up to 5pm.through registered post / speed post only.

**A. Tender paper fee and EMD :**

The tenderer should furnish the EMD of Rs.5000/--(Rupees Five thousand only) (refundable) and Rs. 1000/- towards tender paper fees (non refundable) if downloaded from web site in shape of bank draft in favor of Superintendent, SVPPGIP, Cuttack payable at SBI, main branch Cuttack. The EMD of the non qualified bidders will be returned after opening of technical bid within one month. The EMD of qualified bidders will be returned after completion of the tender process without interest.

**SECURITY DEPOSIT-**

The selected firm has to submit bid security of Rs. 50000/- in shape of demand draft as bid security after which work order will be issued.
