- 3. The sealed tender will be received by the undersigned on or before 15/11/2019 up to 4.00 pm through Regd. post/Speed post only and will be opened on 18/11/2019 at 2.30 pm. Tenderer or their authorized representative should be present during opening of bid. If the tenderer fails to turn up to be present at the time of opening of the tender that will not be a bar for the authority to open the tender. The tender received beyond the scheduled date and time will not be taken into consideration. Any change in date of opening of tender will be intimated by telephone and by E-mail.
- 4. The bidders qualify in the technical bid will be eligible for financial bid opening.
- 5. The firm should quote overall maximum discount above publisher's price on all books and journals of Indian and foreign publication. If the firm quote different discount on books and journals wise that will be rejected.
