TERMS & CONDITIONS FOR HIRING OF VEHICLES:-

The following terms and conditions must be fulfilled by the successful bidder for providing vehicle on hire on monthly rent basis.

- 1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as :- valid registration certificate, Contract carriage certificate, Insurance Certificate, Fitness Certificate, valid pollution certificate, affixed with valid HSRP number plate, proof of up-to-date Tax Payment etc. and valid D.L. (for LMV transport) of the driver available all the times.
- 2. The authority hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life /injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- 3. The hire charges to be paid for monthly basis is final but does not include cost of petrol, which is to be paid separately basing on actual consumption and as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery, puncture of tyres & tubes, Tube pressure fill up & checkup etc. will be borne by the bidder.
- 4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- 5. In case of breakdown, servicing & repairs of the assigned vehicle for reasons whatsoever, the replacement of a vehicle of the same or better model shall be provided immediately by the owner of the vehicle / bidder. No extra amount will be given to the bidder for happened of above mentioned such incidents.
- 6. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
- 7. The vehicles shall report for duty for minimum of 25 days in a month.

- 5. Declaration through affidavit before Notary Public / Executive Magistrate regarding non-black listed by any state Govt. or Central Govt. organization at the time of submission of the bid by the bidder.
- 6. The bidder indenting to apply for this bid shall abide the terms & Condition in Annexure I & II and "Other term and conditions" and shall have complete information the form in Annexure-III along with the bid documents. Any laps thereof will liable for rejection.

- IV. Agency to ensure that all maintenance work related to assigned vehicle shall be carried out in off duty hours.
- V. In the event of break-down, servicing & repairs of the assigned vehicle the service provider at his own cost shall make alternate arrangement by providing similar or higher class of vehicle(s) for which agreement is entered into. Failure to do so will evoke penalty or possible termination of contract.
- VI. The Agency shall not be allowed to sub-let the Contract by giving the engaged vehicles on hire to private party during the period of contract.
- VII. The Agency shall only provide vehicles which have the comprehensive insurance.
- VIII. Police verifications for deployed driver shall be ensured by the Agency.
- IX. Agency shall update the log book at least once in every 24 hours. Failure to do so shall be penalized as per this contract. At the time of termination of contract, the service provider shall hand over the log book (s) to the Superintendent. If the service provider fails to deposit the log book then EMD/Security deposit shall be treated as forfeited.

Vehicles:

- X. The vehicle should have commercial license. The vehicle should not be more than three years old from the date of the Service request.
- XI. The Agency will deploy the vehicle, which is well maintained, cleaned thoroughly both internally and externally. Vehicle shall be equipped with medical kit. The vehicle should have a mobile charger and ambient freshener.
- XII. The Agency shall ensure that all electrical connections including lights (both brake and front), horn, turn indicators, and other vehicle systems shall be periodically checked and maintained by Service Provider to avoid any inconvenience to user department.
- XIII. Agency shall ensure that the vehicle should be parked at the place as advised by the Superintendent and should be available, when not in duty. If the vehicle needs to be away for some reasons like refuelling, petty repairing etc., it should be with the knowledge of the Controlling Officer of the Superintendent. Moving away without the knowledge of the Controlling Officer of the Superintendent will be considered as non available and will be liable for penalty.

XIV. The Agency shall provide at his own for any other provision as per STATE MOTOR VEHICLES RULES (amended up to date) for the vehicle.

Driver:

The Agency shall be responsible for the acts and deeds of drivers of the vehicles that include following:

- XV. Drivers that possess a valid commercial driving license shall be deployed by the agency.
- XVI. Driver should be properly dressed in neat and clean attire, if required driver should wear uniform of specific colour as per requirement of the Superintendent. The Agency shall provide at his own cost proper uniform and badges and any other provision as per STATE MOTOR VEHICLES RULES (amended up to date) and photo identity cards to the drivers.

The driver of the vehicle deployed for user department should maintain polite & courteous behaviour to the officials of the Department. Following may be construed as "Misbehaviour" and shall attract penalties as per provisions of the contract. Repeated instances may result in termination of services

- i) Denial of duty during contract period, or during office hours as noticed by user departments;
- ii) Use of abusive language;
- XVII. The driver in no case shall report to duty in an inebriated state or consume alcohol while on duty. In such an event, user department shall have full rights to terminate the contract with immediate effect.
- XVIII. Driver must be provided a working mobile phone and contact number be provided to user department.
 - XIX. In an event that for any reason the driver changes his contact number during the tenure of the contract, then Agency will immediately notify the user department of the above change.
 - XX. The driver shall be reachable at all times during duty hours.
- XXI. Gossiping with the guests and using mobile phone during driving is not allowed. In case of urgency, driver should park the vehicle with permission from the user and talk in the mobile to the minimum duration.
- XXII. As soon as the driver is advised to attend any quest by administration, the driver should call /SMS the guest giving his mobile and vehicle details. Charges of calls /SMSs will be on

XXIII. Vehicle and driver should not be changed frequently. Any such changes should be informed by the agency to the authority well in advance for permission.

Driver has no criminal activities & agency need to submit the police verification documents after approval of the contract.

The driver shall not drink alcohol & not use of abusive language during duties. If such criminal activities found then the driver discharge his duty on the same time and agency should arrange other driver having valid LMV license

Statutory Rules compliance & Taxes:

- The hiring charges do not include fuel cost (petrol) which is to be paid separately basing on actual consumption. All the expenditure of the vehicle towards repair maintenance, replacement of spare parts, lubricating oil of engine: Gear Box & differential coolant, Tyres & Tubes, Battery puncture of tyre, tube pressure checkup etc. and salary of the driver, payment of insurance/Road tax etc. required for operation of vehicle in a state will be borne by the Agency.
- II. The Agency shall take comprehensive insurance cover with third party unlimited liability risk of the vehicles detailed for the user department requirement. User shall not be liable for any damage whatsoever to public property and/or any third person due to any accident arising out of and in the course of deployment of service provider's vehicle.
- III. The Agency shall be solely responsible for any claims by any third party and/or employees of user department travelling in the vehicle for any injuries caused by the driver of the vehicle whether by accident or otherwise.
- IV. The user department will in no way be responsible for violation of traffic rules and/or infringement of any other law for the time being in force, either by the driver of the vehicle or by the service provider. The driver as well as Agency shall comply with relevant rules and regulations of Motor Vehicles Act and Rules applicable at present or in future during the tenure of the contract and as may be enforced from time to time for which user departments would not be held liable/responsible in any manner what so-ever. Onus of compliance of all the applicable Laws/Acts/Rules including those under Motor Vehicle Acts/Rules shall rest with the Agency only and user/user departments will not be liable in any manner.

- V. The Agency shall be responsible for ensuring compliance with the provisions related to Labour Law and especially Minimum Wages Act, Payment of Wages Act, PF, ESI Act, Payment of Bonus Act, Contract Labour [R&A) Act, Workmen Compensation Act etc. as applicable from time to time. The employees of the Agency shall not be deemed to be employees of the user department and hence the compliance of the applicable acts laws will be the sole responsibility of the Agency.
- VI. The Agency shall be personally responsible for any theft, misconduct and/or disobedience on the part of drivers so provided by him.
- VII. During the contract period, if the vehicle is seized or detained or requisitioned by Police/Motor Vehicle Authority or any other authorities for whatsoever reasons, that will be at the service provider's risk. Also, alternate vehicle of similar or higher category will be provided by Agency without any extra charges.
- VIII. The vehicles deployed for duty for the user department shall at no point of time carry any person other than personnel authorized by user department.
- IX. The vehicle cannot be put to any private/commercial use beyond the duty hours or on holidays. Unauthorized use of the vehicle by the driver/service provider will lead to unilateral termination of the contract with immediate effect. The Agency has to ensure safety of passenger by avoiding negligent driving by their drivers such as over speeding, rash driving and driving vehicle without brakes/defective brakes.
- X. The mileage count will start from the location of pickup and no extra kilometres from the garage to the point will be provided. The mileage count will also terminate at the dropping point and not up to the garage.

5. The obligations of Superintendent:

I. The Superintendent shall make the payment towards hiring charges of the vehicle at the end of every month by credit into the bank account of the Agency through ECS/RTGS within 15 days from the date of receipt of bills complete in all respect. User department shall pay the vendor all amounts on an invoice that are not the subject of a bonafide dispute within 15 days after department's receipt of a valid invoice that complies in all material respects in terms of this Agreement; In case of non-available of fund due to want of allotment from Govt., the agency will not stopped the service without any force for payment of bill.

II. The payment shall be subject to any deductions such as penalties, statutory deduction etc.

- III. The Superintendent shall accept the log book entries updated by Driver. Failure to take action on log book entries updated by Driver shall result in auto acceptance of reading provided by service provider.
- IV. The Superintendent shall be responsible for costs relating to fuel, toll gate charges, parking charges between services and other statutory levies, if any, paid during the journey would be billed on actual and shall be paid by the Superintendent.
- V. All distances shall be calculated from the reporting point. No payment shall be made for journey from garage to reporting point.

6. Terminations:

- I. The Superintendent shall have the right to terminate this Agreement, upon it giving 1 (one) month notice in writing.
- II. The Agency shall have the option to terminate this Agreement upon giving 1 (one) month notice in writing and upon refund of any rental fees paid in advance, over and above the notice period.
- III. Final payment after termination of the contract shall be released on submission of the log book(s) of the vehicle, car pass and pass/id card issued to the driver ,if any.

7. Force majeure

Neither party to this Agreement shall be liable for failure to perform any of its obligations hereunder if prevented from doing so by reason of force majeure.

8. Entire agreement

This Agreement together with the schedules and annexes hereto constitutes the entire agreement and understanding between the Parties and supersedes all previous agreements, understandings and/or representations between the Parties.

9. Waiver of remedies

No forbearance, delay of indulgence by either Party in enforcing the provisions of this Agreement shall prejudice or restrict the rights of either party nor shall any waiver of its rights operate as a waiver of any subsequent breach and no right, power or remedy herein conferred upon or reserved for the Party is exclusive of any other, power or remedy available to the Party and each such right, power or remedy shall be cumulative.

10. Assignment & change in ownership/management:

- I. The Agency shall not assign or transfer its obligations and or rights under this Agreement to any third party, whether an associated entity or not, whether in whole or in part without the prior written consent of the Superintendent.
- II. The Agency shall immediately notify the Superintendent of any change of ownership or management of the Agency's business.
