
### **Official Website**



The financial bid as per the format in Annexure-3 shall be enclosed along with the bid documents in a closed envelop. The bidder qualifies in the technical bid & should have secured at least 60 marks in technical presentation evaluation shall only participate in the financial bid. **The total cost excluding the GST only shall be written in both words and figure.** The cost shall inclusive of one year free maintenance of the website from the date of complete hoisting. **The subsequent AMC cost shall be reflected in the price bid.**

## Evaluation of Proposal

---

1. Information provided in other than the format mentioned will not be considered for evaluation.
2. Financial bids for only those bidders shall be opened who will be qualifying the technical criteria and needs to score least 60 marks in technical presentation evaluation.
3. Only fixed price financial bids indicating total price for all the deliverables and services specified in this bid document will be considered.

## Evaluation Criteria

---

## Evaluation Criteria for Technical Proposal

The evaluation committee appointed by SVPPGIP will assess the proposals submitted by the bidders, considering the criteria as prescribed in the RFP document:

### Resources required

SVPPGIP reserves the right to interview proposed resources of the selected bidder and advise for changes which shall be executed within 7 days of communication.

### Evaluation of Financial Proposal

The bidder must submit their financial bids as per the format (given in annexure) mentioned in the bidding document. SVPPGIP reserves rights for deletion of any component on its own discretion prior issuance of LOI. However, for financial evaluation, the consolidated project cost (including AMC for one year) quotation shall be considered.



## **Rejection criteria**

Besides other conditions and terms highlighted in the Tender Document, bids may be rejected under following circumstances:

### **General Rejection Criteria**

Notwithstanding to the conditioned above, the following conditions shall be adhere to

1. Conditional Bids;

4. A non-refundable processing fee of Rs.1000/- should be submitted in the form of a Banker's cheque/Demand Draft drawn in favor of Superintendent, SVPPGIP, Bhubaneswar from any Nationalized bank.
  5. As Tier-III vendor of OCAC having Start-Up India and Odisha registration under MSME are required to deposit Rs.5000/- as EMD and others are required to deposit Rs.20000/-, drawn in favor of the Superintendent, SVPPGIP, towards EMD from any Nationalized bank, should be submitted along with the sealed quotation. 
