TENDER DOCUMENT FOR PRINTING OF MATERIALS

1. Sealed tenders are invited from interested registered firm for supply of BMW logistic items on rate contract basis during the year 2024-25.
2. Interested bidders have to download the bid documents from institution website available at www.svppgip.org directly. The sealed tender will be received through Registered Post / Speed Post on or before Dt.23/09/2024 by 04:00 PM. The bids received other than mentioned way shall not be acceptable. The bids will not be accepted after last date and time Specified in the tender document.
3. The tender will be in two parts i.e. technical bid. (Cover-A) and-price bid (Cover-B). The bidders should give their technical and financial proposal separately in two envelopes and should be put into another cover super scribed as "Tender for BMW logistic materials.
4. The tender paper cost Rs.1000/-and EMD amount Rs.5000/- in the form of DD to be made separately and to be enclosed with technical bid
5. The technical bid will be opened on dt.25/09/2024 at 03 P.M in the office chamber of Superintendent, SVPPGIP, Cuttack.
6. Bidders who qualify in the technical bid will be eligible for financial evaluation. Supply order will be place as and when required.
7. It would be the responsibility of the Bidder's representative (only one person per bidder) to be present at the venue of opening of Bids. In case absence of any bidder then bid document could be opened by the committee members.
8. The bidders shall ensure that each page of the tender document is to be signed with authorized signatory and company seal.
9. The quoted price shall remain valid for 1 year from the date of approval.
10. The items should be supplied within 14 days (two weeks) from the date of purchase order / award of work. Superintendent, SVPPGIP, Cuttack reserves the right to cancel the order in the case of delay in delivery of all the items.
11. The items delivered should be as per the specification mentioned with clear visibility of contents. If found defective, the same has to be replaced immediately within seven days & total cost will be borne by the concerned awarded party.






LIST OF ITEMS IN TENDER WITH SPECIFICATION

Sl no	Name of the items	Specification
1	Syringe needle Terminator	<ul style="list-style-type: none"> ➤ Should be electrically operated, light weight, portable, and compact. ➤ Housing should be molded type shock proof and made up off ABS plastic. ➤ Should provide a removable discharge tray made for easy disposal of syringe hub. ➤ Should have the provision to burn the needle & to cut the syringe tips. ➤ Should have a high carbon steel cutter to cut syringes. ➤ Should have able to destroy needles of type up to 18G ➤ Should be able to destroy minimum of five injection needles on continuous operation. ➤ Should have a heavy duty transformer of copper winding and works on 220-240 vac/50Hz electric supply. ➤ Should have a power on/off switch and an indicator for power. ➤ Should be properly insulated for protection from electrical hazard. ➤ Should provide with five no's of fuse of adequate rating. ➤ Product should be ISI mark
2	Black Polythene,(size-L-36", W-30")	<ul style="list-style-type: none"> ➤ Should be made up of biodegradable polythene ➤ Should be thickness above 55micron and size of L-36", W-30" to carry 50kg - 60kg volume capacity waste.
3	Plastic Bucket, Black/Blue/Yellow/Green/Red with cover	<ul style="list-style-type: none"> ➤ 50ltr capacity ➤ Should be made up of biodegradable material
4	Sharp Container,5 ltr	<ul style="list-style-type: none"> ➤ The container should be made up of heavy duty plastic. ➤ Should be able to close with a wide mouth tight fitting, puncture resistant lid, without sharp being able to come out. ➤ Should be upright and stable during use. ➤ Should be leak resistant ➤ Properly labeled to warn hazardous waste inside the container.
5	Sodium Hypochlorite Solution,4%	<ul style="list-style-type: none"> ➤ Chlorine percent by mass by volume=5.8 ➤ Relative density(at 25/c)=1.11 ➤ Conforming to IS 11673 ➤ Test report by central govt./NAB/ILAC accredited lab to prove conformation to specification ➤ Free sodium carbonate 0.5gm/l,Iron(max)ppm=0.4, Sodium Chloride=0.5gm/l ➤ Packing in ltr ➤ Packaging type-Air tight plastic jar.

5. Copy of PAN Card
6. Copy of IT Return for the year 2022-23 (Assessment year 2023-24)
7. Self declaration of non-blacklisting of their firm.
8. Supply order copy of at least one year of BMW products to any Medicals of Odisha

PRICE BID:

1. The price bid of firm/s who qualified in the technical bid will be opened.
2. Hard copy of signed and sealed both words and figures. In case of difference of words and figure, the rate in figure will be taken into consideration.
3. Any correction in word, the rate is accepted as noted in figure.
4. Any correction in figure will not be taken into compare in price bid.
5. The net quoted price (including all tax, Levis if any & transportation) excluding GST should both in figures and words. In case of difference in words and figures words will be taken in to consideration for evaluation.
6. The sample of the quoted item/s to be submitted which will be returned to the bidder after finalization of tender.
